

SAON Board meeting 10th March 2021 16-17:30 CEDT / 10-11:30 am EDT / 15-16:30 UTC Teleconference Minutes

1. Introductions and adoption of agenda

Sandy Starkweather (Chair) welcomed the participants, wishing all participants a Happy New Year. The agenda was adopted (Appendix 1). The list of participants is found in Appendix 2 and the list of documents is found in Appendix 3.

2. Committees

2a ADC

Jan Rene Larsen (SAON Secretariat) reported that the ADC continues to arrange the series of *Polar to Global Online Interoperability and Data Sharing Workshop/Hackathons*. The next would we held in April. One of the tasks is about data policies. The planning for the fourth Polar Data Forum is ongoing.

2.b CON

Lisa Loseto (CON chair) summarised recommendations from the CON governance workshop. Four of these had been highlighted:

- The value and relevancy of the national observation inventories needs to be reinforced with SAON Board members; in addition, the ASM3 Ministerial Statement could present an opportunity.
- Strong National SAON Committees are needed as the foundation for the SAON CON, as well as for the SAON ADC. This requirement should be brought forward to the two oversight bodies of SAON, namely the Arctic Council and IASC.
- The upcoming Arctic Science Ministerial 3 meeting represents an opportunity to develop and deliver key messages into the Joint Statement that is released by the Ministers. The Joint Statement could be used to restate the need for strong National SAON Committees, if this was deemed a priority.
- The leadership of the CON should consider having a Chair, a Vice-Chair and a Past-Chair positions. The Vice-Chair would serve in a support capacity to the Chair and move forward to the Chair position at the end of their term. The Past-Chair position would serve as an advisor to the Chair passing along guidance based on their previous Chair experiences.

Follow-up actions to these were proposed in document 09 and were discussed. On the last recommendation on leadership, Lisa Loseto (CON Chair) explained that CON had had discussions about replacing her position and noted that at earlier stages, there had been a co-chair for CON. It had been decided to formulate a posting that covers both the chair and the co-chair, and there had been a discussion on where to share it. If it was shaired internally, that would allow Board and existing CON members to nominate themselves or identify candidates.

In the formulated posting, it was agreed also to solicit interest from permanent participants, since it might be an opportunity to enhance the partnership and engagement with Indigenous participants. In the posting, emphasis was put on the need for motivated individuals, the amount of work was described, and it was explained that this could be an opportunity for early career scientists, who might be interested in networking across international groups.

In the discussion, Heikki Lihavainen (SIOS) expressed concern about the clarity of the text when it comes to what it actually is the announcement should reflect: Chair, vice-chair or co-chairs.

Sandy Starkweather proposed that the announcement should be released at the same time internally and externally.

Eva Kruemmel (ICC) asked if there had been considerations about making the positions salaried position?

Jan Rene Larsen (SAON Secretariat) responded that the SAON budget does not have room for salaries, but that support to travel to and participate in the Arctic Observing Summit and ASSW would be part of the offer. He noted that the principles for the position should also apply to the ADC.

Larry Hinzman (IASC) noted that when you are employed in certain positions, then you cannot receive a salary and that the payment should be called a honorarium. He noted that a committee chairmanship still is major effort, and that the candidate should be somebody inspired to do the job.

Eva Kruemmel proposed that this was something that could be a topic in the context of the governance discussions.

Sandy Starkweather recommended that it would be useful for SAON to have a compensation policy to guide the work within SAON and that the concept of an honoraria is more relevant than salary.

Jan Rene Larsen noted that if there is a situation where there are several nominations, then there would be a need for a panel to review applications and to agree on the right candidate.

3. SAON Governance review

The next workshop to be held would be on national SAON organisations/structures, and Helen Joseph (HCJ Consulting) had prepared a draft agenda that was discussed. The agenda and proposed list of invitees were agreed. Mikko Strahlendorff (vice-Chair) had offered to be the champion for the workshop.

In contrast to earlier workshops, it was less obvious what the outcomes workshop would be. Should for instances guidelines, mandates, terms of reference, or similar be developed for the organisations? Or should there be focus on on defining 2 or 3 practical tasks?

Eva Kruemmel added the importance of inclusion of indigenous representatives in the national SAON organisations/structures.

Doug Cripe (GEO) explained that GEO has an 'Indigenous Alliance' that could be engaged.

4. Arctic Science Ministerial

Hiroyuki Enomoto (Japan) explained that the joint statement from the Ministerial is under approval. ASM3 will be a hybrid conference with physical presence as well as remote attendance. The four known themes will be covered with two themes per day over the two days of the Ministerial.

5. Arctic Observing Summit 2022

Gerlis Fugmann (IASC) reported that the local organizing committee for ASSW 2022 has met a couple times and are getting the basic logistical things in place. The ASSW web site will be launched in early April. Jan Rene Larsen added that for AOS itself, a small initiating group had been established and has met a couple of times.

7. Any Other Business

7a. SAON 10 years

Jan Rene Larsen explained that the Arctic Council, Nuuk Declaration from May 2011 was the place where the Arctic Council decided that SAON should be established. As part of the Arctic Council Ministerial, an issue of the magazine 'Pathways' will be published and there will be an article on SAON.

7b. Developing an antiracism statement / code of conduct

Sandy Starkweather proposed that a small group of Board members should convene under this topic. She noted that there is not necessarily great diversity and representation in SAON activities and believed that it would be valuable for SAON to consider own structures that might unintentionally reinforce that. She had noted that in US national organizations, Indigenous people who are considering whether to engage in these, pay attention to what is in place, in terms of making participants equitable.

7c. SAON/ROADS brochure

The original intention was to present this as a physical brochure at the ASM3. Since this would no longer be a physical event, the decision was to prepare this for another relevant event.

7d. Requests to SAON for Letters of Support

It was agreed that the Secretariat should formulate a proposal on this. A draft is under development in IASC and should serve as inspiration.
